1 Briefly describe the organization's mission: THE IMMUNE DEFICIENCY FOUNDATION (IDF) IS THE NATIONAL PATIENT ORGANIZATION DEDICATED TO IMPROVING THE DIAGNOSIS, TREATMENT AND QUALITY OF LIFE OF PERSONS WITH PRIMARY IMMUNODEFICIENCY DISEASES (PI) THROUGH ADVOCACY, EDUCATION AND RESEARCH.

IN 2018, APPROXIMATELY 17,470 ATTENDED MORE THAN 224 PRESENTATIONS IN 109 CITIES IN 32 STATES AND THREE COUNTRIES. THESE INCLUDED LOCAL EDUCATION MEETINGS, GET CONNECTED MEETINGS, IDF RETREATS, TEEN ESCAPE WEEKENDS AND MEDICAL EXHIBITS. IDF COORDINATES AN OUTREACH PROGRAM WITH PLASMA COLLECTION CENTERS THROUGHOUT THE COUNTRY. APPROXIMATELY 2,350 PEOPLE WERE REACHED IN 56 VISITS TO PLASMA CENTERS THIS YEAR. OVER 292,000 IDF EDUCATIONAL MATERIALS WERE DISTRIBUTED.

LOCATING A SPECIALIST WAS THE NUMBER ONE NEED WITH 1,258 REQUESTS. IN TERMS OF PUBLIC ADVOCACY, IDF WORKS THROUGHOUT THE YEAR TO EDUCATE PATIENTS ABOUT ISSUES, ON THE FEDERAL AND STATE LEVELS, THAT IMPACT THE PI COMMUNITY. IDF CONTINUES TO DEVELOP ITS STRONG VOLUNTEER GRASSROOTS ADVOCACY NETWORK TO EDUCATE POLICYMAKERS ABOUT ISSUES AFFECTING OUR COMMUNITY. THIS YEAR THERE WERE OVER 2,000 LETTERS AND CALLS TO POLICYMAKERS. THE ANNUAL IDF ADVOCACY DAY ON CAPITOL HILL GATHERED 49 VOLUNTEERS WHO MET WITH MEMBERS OF

PI CONNECT, THE IDF PATIENT POWERED RESEARCH NETWORK WHICH IS ACCESSED THROUGH IDF
